1. Pushes the POWER button						
2. Connects the temperature adapter cable to the TEMP port on the device.						
3. Connects the temperature probe to the temperature adapter cable.						
4. Attaches the temperature probe to the patient as described in the temperature probe Instructions for Use.			Note: the temperature probe may require 3 minutes to equilibrate after placement on the patient monitoring site.			
5. Confirms the temperature reading appears and is stable.						
6. Describes the three channels available for temperature monitoring with labels T1, T2, & T3. Label locations include: • Esophageal • Bladder • Rectal • Skin						
7. Describes the process to change or label a location on the device.						
8. Describes the process of cleaning reusable
