CAPITAL LETTERS indicate labels, screen messages, and voice prompts. "Push" is used when referring to keypad buttons, and "Press" is used when referring to softkeys on the touchscreen indicated by italics

2. Insert the lead attachments into the main cable.			
3. Attach the ECG cable to the green connector monitor .			
4. Prepare the patient's skin for electrode application according to local protocol or Operating Instructions			
5. Apply ECG electrodes.			
6. Press the 12-LEAD button at the bottom of the Home Screen. The LIVE view appears and shows all connected ECG Leads.			Note: If a 10-wire cable is attached, the LIVE 12-LEAD view appears, showing all 12 leads. If a 13-wire cable is attached, the LIVE 15-LEAD view appears. Scroll up or down to view the additional leads.
7. Press ACQUIRE at the top right corner of the LIVE screen.			Note: The first time you press ACOUIRE , the DEMOGRAPHICS dialog box appears
8. Enter patient's sex, age, and race in the DEMOGRAPHICS dialog box.			Note: If sex and age were already entered into the patient record, they will be automatically filled in and cannot be changed in dialog box.

9. When the device is finished acquiring and analyzing the ECG, an ECG report appears.		
10. Press the TRANSMIT button at the top of the onscreen report. 12-LEAD 2 - 19:25:04 IV <		Note: Transmission sites that accept 12/15-lead reports must be set up in your LIFENET account to enable this feature.
11. Select test site to transmit to.		Note: If prompted for a transmission site selection, choose 'Test' site. It is not recommended to transmit to another organization for the purpose of testing.
12. To transmit a previously-acquired 12/15-lead report, press the down arrow shown to open the 12-lead report list.		
13. Press the report to view and transmit.
